Associate Membership: Associate Members will receive ALL publications issued by the Society. Are NOT entitled to register any animals in their name. Are NOT entitled to issue service certificates. Are NOT entitled to vote at any meetings where a vote is taken. It is mainly a “social” membership to receive any publications.

Full Individual Member will receive all publications. May register animals in their name, May enter Pinto Shows. Are entitled to one vote per Membership at any Meeting where a vote is taken, & entitles the person to stand for election to Committee. refer*96 **NOTE:** Persons under the age of 18yrs shall be eligible to join as a FULL member but they shall not be entitled to hold office or vote.

A Full Joint Membership shall consist of no more than two persons over the age of 18yrs. A Joint Membership entitles the persons listed to one of each publication issued by the Society. May register animals in their name, May enter Pinto Shows. Persons listed on a Joint Membership shall only be entitled to one vote at any meeting where a vote is taken. Entitles one ADULT member to stand for election to committee. refer*96

A Family Membership shall consist of no more than two adults and their children that are 18yrs of age and under. A family that holds a Family Membership shall only be entitled to one vote at any Meeting where a vote is taken. A family Membership entitles the family to one of each publication issued by the Society. May register animals in their name, May enter Pinto Shows. Children listed on the Membership Form shall be deemed financial for the purpose of being eligible for youth high point awards and eligibility to compete in Junior Member classes at shows held by this Society. Entitles one ADULT member to stand for election to committee. refer*96

***96. Eligibility to Stand for Committee**

Any Person wishing to nominate for Committee must have been a full financial Member of this Society for at least one complete financial year, prior to and leading up to the year in which they are nominating.
